**Rates:** Rates shown in this tariff are for a single conventional tug docking or undocking only.

**Overtime:** Services performed between 7:00 pm and 7:00 am will incur an additional charge of 35% of the tariff rate. Overtime charges are applicable when service either commences or completes in an overtime hour. In addition, overtime services will be charged all day Saturday, Sunday and Holidays.

**Holidays:** New Years Day, MLK Birthday, Presidents Day, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day and Christmas Day.

**Hourly Rate:** A rate of \$863 per hour or fraction thereof per tug will be charged. The hourly rate will commence upon the tug leaving its berth and terminate upon the tug's return to its berth. Hourly rate is not subject to discount.

**Escorting:** Should vessels require escorting below the Intracoastal Canal, the hourly rate would apply. For arriving vessels, time will commence upon the tug leaving its berth and terminate when the tug escort reaches the Intracoastal Canal after which, the prevailing tariff will apply. For sailing vessels, the prevailing tariff will apply until the tug escort passes the Intracoastal Canal; time will then commence and count until the tug returns to its berth.

**Tractor Tug Rate:** When a tractor tug is used, all applicable rates will be increased by 50%.

**Fuel Surcharge:** All charges are subject to prevailing fuel surcharge. Fuel surcharge is not subject to discount.

**Notice:** Notice is required a minimum of 4 hours prior to arrival and 2 hours prior to sailing to ensure service.

**Waiting Time:** One hour waiting time is free after which a fee of \$863 per hour or fraction thereof per tug will be charged to a vessel.

**Cancelled Sailing:** When a tug is ordered and then cancelled, a fee of \$863 per hour or fraction thereof will be charged basis the time the tug leaves its berth until it returns to its berth.

**Security Charge:** A fee of \$86 will be applied to each invoice to cover ISPS, US Government and other security requirements.

**Emergency Towing, Vessels Aground or in Distress:** The terms of this agreement do not apply to vessels aground or in distress. Such services will be performed under our Emergency Services Contract. Rates quoted on request.
